

THE MEADOWS RACETRACK AND CASINO (To Be Signed by Trainers)

THIS SECTION MUST BE CAREFULLY READ AND SIGNED BY THE APPLICANT PRIOR TO BEING PERMITTED TO ENTER THE MEADOWS RACETRACK AND CASINO FACILITY FOR ANY PURPOSE. including but not limited to restricted areas, racing surface, infield, paddock area, grandstand/clubhouse area, construction areas and all walkways, concessions, and other areas appurtenant to any area where any activity to an event shall take place (the "Facility"), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in any event in the Facility. The undersigned, for himself/herself, his/her personal representatives, agents, heirs and next of kin, acknowledges, agrees, and represents that he/she has, or will immediately upon entering the Facility or any restricted areas, and will continuously thereafter, inspect such areas and all portions thereof which he/she enters and with which he/she comes in contact, and he/she does further warrant that his/her entry and his/her participation, if any, in any event at the Facility constitutes an acknowledgment the he/she has inspected, and will continue to inspect, such areas and that he/she finds and accepts the same as being safe and reasonably suited for the purposes of his/her use, and he/she further agrees and warrants that if, at any time, he/she is in or about such areas and he/she feels anything to be unsafe he/she will refuse to participate further in the event, will immediately advise the officials of such unsafe conditions and will promptly leave the areas.

The undersigned trainer (Agent) represents that he/she is authorized the horse(s) and owner for each and every horse listed. The authorized Agent (trainer) agrees to be bound to the by the terms herein for each horse to have considered for racing privileges at Washington Trotting Association/ Mountain Laurel Racing (WTA/MLR) Race Meetings. The WTA/MLR are members in good standing in the United States Trotting Association ("USTA"). No individual may participate as an owner, trainer, or driver unless he or she is a member in good standing and licensed, as such, with the USTA. The Rules, Regulations, Policies, and Procedures of the Pennsylvania State Harness Racing Commission (The "Commission"), the USTA and WTA/MLR shall govern the conduct of the meetings and all owners, trainers, drivers, and caretakers are subject to the same.

The Agent agrees to keep a list of horses herein for which the Agent is authorized to act up to date. This information is designed to assist and enhance the quality of racing at the start of WTA/MLR race meetings and/or the Agent's first starts at the meetings. All authorized Agents are expected to notify the Racing Secretary at The Meadows Racetrack and Casino with any changes hereto within forty-eight (48) hours of said change.

It is clearly understood and agreed that this application does not constitute a lease of any space, but is merely a revocable permit granted by WTA/MLR based on the terms and conditions set forth herein and may be changed, altered, or rescinded at any time at the sole discretion of WTA/MLR. WTA/MLR may refuse admittance to or eject from the Premises any person or horse considered undesirable by it in its sole discretion. Only those trainers and driver approved by management of WTA/MLR are authorized to enter the Premises and participate in meetings. WTA/MLR reserves the right to refuse and/or terminate and prior license or permit granted in response to this application for racing privileges in whole or in part and/or refuse the acceptance of any entry in any race for any reason or cause with or without notice to the undersigned. The undersigned acknowledges that WTA/MLR, The Meadows Racetrack and Casino, their affiliates, and their respective owners, parent companies, employees, officers, agents, servants, successors, will not be liable or responsible for any loss suffered in any manner by to the horse or horses or equipment or personnel of the undersigned while on or off the premises or while being transported in any matter on or off the premises, irrespective of the cause of such injury or loss. The Undersigned releases and holds harmless WTA/MLR, The Meadows Racetrack and Casino, their affiliates, and their respective owners, parent companies, employees, officers, agents, servants, successors from and against all claims for injury or loss by or on behalf of the undersigned as well as from all costs, loss, damage, liability, or negligence of the undersigned or any of the undersigned's employees or agents.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no coercion or oral representations, statements, or inducements apart from the foregoing written agreement have been made.
